Abstract The purpose of this study was to determine the effect of a 12-week training program on the heart rate (HR) and blood pressure (BP) of sedentary, middle-aged men. The subjects were randomly assigned to a control group (CG) and an exercise group (EG). The EG performed a 12-week training program consisting of aerobic and resistance exercises. The CG performed no exercise. The HR and BP were measured at baseline and at the end of the 12-week training program. The results showed that the EG had a significant decrease in HR and BP compared to the CG. The decrease in HR was 10.5 ± 2.5 beats/min, and the decrease in BP was 12.5 ± 3.5 mmHg. The CG had no significant change in HR and BP. The results suggest that a 12-week training program can effectively reduce HR and BP in sedentary, middle-aged men.
